School/Ted Carter

- Ted Carter has been appointed as School Board to be the Liaison to the Board of Selectmen for preparation of School Budget for the 2022/2023 School Year and June Town Meeting.
- Budget in Progress. A financial update for the school is attached and things are looking good financially, with an estimate of \$249,000 to be available to offset next year's budget. Recommended to keep 10% of their budget approximately \$130,000 in reserve.
- The Alexanders portion of the Superintendent's Office is expected to go down.
- AES only has 36 students (less than expected last spring).
- State plans to do 55% State Subsidy and an ME Revenue Sharing of 5%.
- Building is in great shape, were able to renovate the garage due to Covid money

 Alexander School Board meets the 2nd Tuesday of every month at AES beginning at 6:30 p.m. Everyone is welcome, the board will continue to work on the budget.

AES Warming Shelter/Kristy Crawford

- The Town Office received an email (see attached) in regards to the school being used as a shelter as they received a grant for a generator
- Selectmen in agreement that this needs to happen. Ted Carter agreed and suggested that Principal Trevor Flood be contacted and the School Superintendent. The hope is that people will call the town office (phone calls will be forwarded to Kristy) and Kristy will contact those supervising the school opening.
- Who will supervise the building? Both Ted Carter and Skip Colson offered to take shifts.
- Kristy Crawford will contact Principal Flood and see what arrangements need to be made.

Planning Board and Board of Appeals/Ted Carter & Skip Colson

- Ted has contacted Andy Snowman.
- Selectmen cannot be on the Planning Board of Appeals.
- The Planning Board of Appeals needs a new member, and needs to be appointed by the Selectmen.
- Members should have staggering years.

- Computer has been set up for the Planning Board to have access for their use, minutes, forms, letter writing, etc.
