- June 5th minutes missing, James Gibson Jr. had not supplied them, thus approval tabled until the next meeting.

Skip Colson

- At the last Planning Board Meeting a typo was found in the Shoreland Zoning.

 Andy Snowman recommended that the correction be brought to the selectboard to be voted on and when approved be added to the Town Website.
- The next Comprehensive Plan Committee Meeting will be on July 14th at 6:00 p.m. at the Municipal Building.

Mowing

- By consensus of the Selectboard, Carl Oakes will begin mowing the Municipal Building yard and to pay David Davis for the previous mowings.
- A motion was made by John Knowles to have the town roads mowed by David Davis, 2nd by Kevin Dean, 3 in favor (Kevin, John, and Foster) 1 Abstention (David Davis as he was being hired).

Bromley Property

• Selectmen signed the property release for Mr. Bromley (quick claim deed to be issued)

Meddybemps Shore Street Light

- After much discussion the Selectboard agreed by consensus that the town is not responsible for street lights on private (camp) roads. If they do for one, they'd have to do for all.
- It was suggested that perhaps the Meddybemps Shore Association could approach the state for signs to be placed on Rte. 9 for turning traffic, entering traffic, and or school bus and plow truck turning.

Pokey Landing

- Discussion included the fact that the agreed upon changes had not taken place and the landing is still being blocked.
- Kevin Dean feels the board has done everything possible to work out a solution.
- Kevin Dean recommends that they take the next step and contact Eaton Peabody (lawyer the town has been working with) and take the next step.
- The board agreed by consensus and Kevin will make the call.

Princeton Airport

- After much discussion the board decided not to join the Airport Authority but to make a one time gift from the ARPA funds.
- Motion made by Foster Carlow Jr. to give the Princeton Airport a one time give of \$1,500.00 from the ARPA Funds. 2nd by David Davis. 3 votes for (Kevin, David, Foster) 1 against, (John Knowles no reason given).

 Motion made by Foster Carlow Jr. 2nd by John Knowles to use ARPA Funds to Refurbish the Road Account for having the Arm Road ditched and culverts replaced. All in Favor.
