Broadband/James Gibson Jr.

- Some homes are ready to be hooked up, 81 sites have been tested and ready to go.
- Folks that have tested sites and have contacted Pioneer should be getting calls for installation.

Town Clerk/Kristy Crawford

- The Grange sent a nice Thank You note for the third party donation.
- 275 Ballots at the last election, everything went well.
- Mr. Doliber is not plugging equipment in at the Salt/Sand Shed at this time and will be reimbursed in the next warrant.

- Mr. Doliber has a camera to watch his loader in the Salt/Sand Shed until he can close the door.
- Should be getting Broadband in the office any day now.
- 2 more mice have been caught and the alarms at the Municipal Building have not gone off since.
- The Special Town Meeting had 11 people in attendance. The only Article on the Warrant passed with a vote of 9-1. The position of Town Clerk/Tax Assessor/Treasurer will now be appointed.
